Developments in the Security Council

Prior to the UN Charter there were no limits of any kind on the use of force by nations.

- Since the Cold War, the SC has significantly activated and broadened its authority and jurisdiction through Article 39's mandate to "maintain or restore international peace and security."
- No mandate to interfere with affairs internal to nations



Developments in the Security Council

BUT read into Chapter VII times appropriate if internal situations were determined by the SC to be "a threat to the peace" due to severe humanitarian crises, ethnic conflicts or large flows of refugees across borders, significant human rights violations and threats to democracy that also threatened to destabilize the region.

• Also generic worldwide threats such as terrorism, proliferation of weapons of mass destruction, non-state entities that are a threat to peace



Developments in the Security Council

"Third generation peacekeeping" (such as in Kosovo and East Timor) where UN-designated forces assume virtually all the function of the governing territories.

- Length of authorization?
- New technical commissions that largely have been effective in postconflict environments and the re-building of war-torn territories in an effort to hasten their re-integration into the world community
- Tension between instruments and frameworks and the ability to prevent or even abate crisis
